Children will be supervised during the two Camp Sessions 9 AM to 12:15 PM and at 1 PM to 4:15 PM. Please make arrangements for your child to be picked up promptly. For safety, please drive slowly in our parking lot. Special medical conditions should be made known to us at pvbiblechurchbasketballcamp@gmail.com before the Camp starts. Basketball is a strenuous sport and only children in good physical health should attend or have specific guidelines given by a medical doctor for any limitations on physical activities. Players wearing glasses should have straps attached to prevent glasses from falling off. Our Camp will best serve the community if players have fun and learn in a safe environment. Ample time will be given to children with special behavior problems. However, if a child's behavior results in injury to others or destruction of property, or if the child leaves the area of Camp supervision without church permission, then the child's parents will be notified and the child will be asked to leave the church premises and not be permitted to return.

AUTHORIZATION TO CONSENT TO TREATMENT OF MINOR

(I)(We), the undersigned, parent(s) of the above mentioned child, a minor, do hereby authorize Pleasant Valley Bible Church Basketball Camp Leaders as agent(s) for the undersigned to consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is to be rendered under the general or special supervision of any physician and surgeon licensed under the provisions of the Medical Practice Act whether such diagnosis or treatment is rendered at the office of said physician or at a hospital. It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care being required but is given to provide authority and power on the part of our aforesaid agent(s) to give specific consent to any and all such diagnosis, treatment, or hospital care which the aforementioned physician in the exercise of his best judgment may deem advisable. I also give my permission for my child to be transported to the nearest hospital as needed. I realize that church insurance begins where the individual's health and accident insurance policy terminates. It is only valid when other insurance has been extended to its limits. This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of California. This authorization shall remain effective July 5, 2021 through July 9, 2021 unless revoked in writing to said agent(s). The intent of this Liability Release is to prevent Pleasant Valley Bible Church and its owners, agents, employees, and volunteers (hereafter "PVBC") from being held liable for injuries to a person or property when users of our facilities are injured as a result of their being present on our grounds whether they are engaging in an activity which we allow or not. Your signature on this Liability Release constitutes your agreement and the agreement of your child for whom you are signing this Release not to hold PVBC, its owners, agents, employees, and volunteers liable for damages, losses, or injuries to person or property including, sickness, or death from basketball and other activities on church premises and including contracting or exposure to the Covid-19 virus or any of its variants, in connection with the 2021 Basketball Camp Program herein. You understand and agree that you are signing for the minor listed on this form and you further understand and agree that signing this Liability Release constitutes a full and complete release from liability insofar as PVBC is concerned and an agreement to hold said PVBC harmless and relieved of any responsibility for any injury or damage to your child. In addition, by signing this form, you acknowledge and agree that any video or photos taken of your child may be used in publications or promotions (i.e. print, video, or internet form) for PVBC and its related ministries without compensation to you, your agents, or your heirs.
